

Call for Suppliers: Registration Form & Declaration of Honor

MedBAN Open Calls











MedBAN - Context

The purpose of this document is to set the requirements and terms of accession to the MedBAN Bank of Suppliers (MBS) that will be listed in the Annex 2 of the Terms of Reference of the Calls' Documents (you will be able to find it in the MedBAN F6S platform page when the calls are open).

The Single Market Programme project MedBAN (Grant Agreement No. 101074763) aims to establish a bank of suppliers that brings together a set of expert entities focusing on providing support services to the EU blue economy Small and Medium-sized Enterprises (SMEs). The focus will be on supporting SMEs in five different sectors of the EU blue economy: sustainable aquaculture, sustainable fisheries, sustainable tourism, marine renewable energies and harbours. It should be noted that, when 'SMEs' are referred to, it is indicating the (potential) applicants to the MedBAN open calls, not to suppliers which are SMEs.

The MBS should provide services that enable the SMEs to tackle the **16 challenges that the MedBAN** project identified within these five sectors in the 'D2.1 - Resilience preparedness-business continuity plan' document which mapped the Mediterranean Blue Economy ecosystem in different countries (France, Greece, Italy, Portugal, Spain).¹

The suppliers can be different types of entities, such as: Private Companies, Research and Technology Organisations (RTOs), Testing Facilities, Universities, Living Labs, Regional Development Agencies, and other actors that can provide high-quality expertise and services on the listed sectors.

The suppliers should be able to provide at least one type of service related to one of the two open calls of MedBAN: the 'Innovation, training and twin transformation' (ITTT) call and the 'Internationalisation' call. The types of services to be provided by suppliers should be related to the topics of each call and include but are not limited to the examples provided in the descriptions of the topics:

Internationalisation call

This call aims for SMEs in the EU blue economy sectors, especially in the Mediterranean region, to go international and boost access to global supply and value chains. The activities will be valued according to their direct contribution to overcome the 16 challenges identified in the MedBAN continuity plan.

Training	Training services tailor-made for the internationalisation of companies. International Matchmaking	Services which encompass the connection with international entities to establishing business partnerships and protocols and collecting important information regarding the target markets.	10 000€

The MBS has been formed to address and meet the needs regarding innovation, twin transition and internationalisation services of EU Blue Economy SMEs. In the MedBAN platform F6S, the MBS members will be listed in a dedicated annex to the terms of reference of the call document, thereby providing them visibility and helping the potential applicants to easily find a specific service necessary to their organisation and to get in contact with a potential supplier from the MBS for providing reliable and professional services.

Over the eight topics of the two calls, the MedBAN project aims to support at least 65 SMEs over a total of 127 selected proposals (96 in the ITTT call and 31 in the internationalisation call), so this could be a very good business opportunity for suppliers in the MBS.

1. Suppliers Management by the MedBAN Consortium

The MedBAN project is not involved in the interaction between the supplier and the SME, as this is of the entire responsibility of the concerned parties. The MedBAN project sets a maximum support amount to the SMEs per service, but the costs to SMEs are negotiated between them and the supplier that will ultimately provide a quotation which the SME will present at the proposal stage.

In case there is any unforeseen event of force majeure at the implementation stage that impedes the supplier from providing the service, the SMEs will be able to contact an alternative supplier from the bank, but the negotiation will be up to the involved parties.

In order to ensure an efficient provision of services from suppliers to the SMEs (e.g. in services that are provided to groups of SMEs and not on a one-to-one basis), the suppliers can (not mandatory) indicate a minimum and a maximum number of SMEs per topic/service to which they are committed to provide the services:

- <u>Maximum threshold</u>: maximum number of SMEs (per topic) that represents the capacity limit of the supplier, accounting for the need to implement the services between September 2023 and July 2024.
 - o Example: 12 SMEs on Consulting, 10 on Acceleration.
- Minimum threshold: minimum number of SMEs selecting a supplier (per topic) that would ensure technical/financial viability for the supplier, accounting for the need to implement the services between September 2023 and July 2024 (10 months).







o Example: 3 SMEs on Acceleration, 4 on Open Innovation.

The default minimum threshold in order for your entity to be included into MBS is one SME. The supplier commits to supply the services on that topic if its minimum threshold of beneficiary SMEs is reached. Regarding the maximum threshold, this is only an indicative value to the MedBAN consortium, since the suppliers will be free to sign (or not) an acceptance declaration with the SMEs for the provision of the services at the time of the proposal (April-May 2023 period), thereby managing their internal capacity limit.

In case a supplier gets under the minimum threshold of beneficiary SMEs that selected its service (at the award stage) as indicated in its registration form, the supplier will not be obliged to provide the services. In this scenario, the supplier has 7 calendar days from the communication of the awarded SMEs to communicate to the MedBAN consortium that it will not provide the services and the SMEs will be able to negotiate with other supplier(s) that reached the minimum threshold indicated in their registration form.

The MedBAN Consortium is setting a maximum of 7 (seven) suppliers per topic/service. Suppliers outside the consortium countries (outside France, Greece, Italy, Portugal, Spain) might exceptionally join over the limit since they might enable applications from SMEs from their countries. The suppliers will be accepted to the bank (in case they meet the criteria) on a first-come-first-served basis. The MedBAN consortium reserves the right to ensure a geographical balance of suppliers within each topic.

2. MedBAN Bank of Suppliers Criteria

The criteria for accepting a supplier into the MBS are the following:

- 1. Two mandatory qualitative criteria
 - I. Provide service(s) to SMEs as part of their usual activity.
 - II. Have expertise in the service(s) they aim to provide.

The supplier is responsible for the correctness of fulfilling the above-stated criteria and of the information they submit in the registration form for suppliers.

3. Benefits and Duties

The supplier intends to avail itself of the benefits of pertaining to the MBS and being referenced in the corresponding annex document to the calls' terms of reference on the MedBAN F6S platform for being accredited as being a recognized and reliable service supplier of the MedBAN ecosystem. Being part of this bank gives entities and the services they provide visibility and can/should lead to new (national and international) service contracts with SMEs, help to increase their B2B contracts, increase their outreach to other sectors and lead to new cross-sectoral and/or cross border research collaborations.







Services should be delivered in English except if both organisations agree bilaterally on a different language or in case the SMEs and Suppliers come from the same country, in which case it could be in their mother tongue.

4. Termination of participation

If the MedBAN supplier fails to meet the demands described in the declaration of honor or breaches substantially the registration form, the MedBAN consortium has the right to exclude it from the Bank of Suppliers listed in the annex to the terms of reference of the calls.

Prior notice of planned exclusion from the MBS, the MedBAN Supplier shall have at least 30 days before the exclusion. The MedBAN Supplier has the right to make an objection in which it has to justify its further commitment to the MedBAN Project.

5. Procedure

The SMEs applying to the MedBAN calls will need to present a signed declaration agreement (e.g. proforma invoice - preliminary bill or estimated invoice for the service) between the SME and the supplier at the proposal stage as part of the application where both entities:

- Declare their agreement in providing/receiving the service within the MedBAN implementation period (September 2023 - August 2024) in a timeline and duration to be agreed between both parties in case the SME is selected for funding (June-August period).
- Set the quotation amount (budget) for the service to be provided to the SME. This amount can go over the maximum grant amount that each SME will get from MedBAN to fund that specific service provision.

This means that SMEs will be contacting potential suppliers (from the MBS) during the application stage (April-May 2023) in order to choose between them and get a signed agreement with the supplier in its application.

The commercial interactions between the SMEs and the suppliers are the full responsibility of both parties and outside the MedBAN consortium's roles.

6. Confidentiality

During the participation in activities in the framework of the MBS, the MedBAN supplier may have access to confidential information. The confidential information shall include but not be limited to requests of SMEs containing technical details such as specifications, sketches and descriptions, contracts, financial information, marketing plans or other business information.







At the request of the SME, a Non-Disclosure Agreement (NDA) needs to be signed between the SME and the supplier before the SME discloses any kind of information to the supplier. The supplier shall not be entitled to disclose confidential information supplied by the SME to third parties for any purpose without the prior written approval of the SME, with the exception of the disclosure of confidential information if it is required by applicable law or decision of a court or a public authority.

- I provide the services in a period agreed with the SMEs and within the 10-month period established by MedBAN for the implementation of these actions (September 2023 July 2024).
- I shall treat all confidential information disclosed to me confidentially and with at least the same
 degree of care as I would for confidential information belonging to myself. I will not, without the
 prior written consent of the SME to which I am providing the service, disclose such confidential
 information to any to third parties for any purpose, with the exception of the disclosure of
 confidential information if it is required by applicable law or decision of a court or a public
 authority.
- I agree that the information that I added in the Registration Form will be made available for the potential applicants (SMEs) to access in the MedBAN calls (Annex of the Terms of Reference).
- I agree to promote the MedBAN F6S platform and project, its ecosystem and its benefits among clients and to provide the information requested by the SME related to the implementation of the action(s).
- I understand and agree that my organisation will receive no financial means from the MedBAN consortium to carry out the activities described in this form.
- I understand that the services provided by my organisation in the framework of the project will be paid by the recipient of the services (client SME) on a B2B basis.

In order for your organisation to get into the MBS, you must send this document (including the







Registration Form and the Declaration of Honour) signed (written signature with blue ink or electronic signature) to medban.eu@gmail.com. You will receive an email communicating the result of your registration request in the MBS after a maximum period of 10 calendar days from the moment you send your request. If your registration is accepted, your entity will be added in the next updated bank of suppliers document (Annex of the Terms of Reference for the call for proposals for SMEs) available in the MedBAN F6S application platform. You can apply to join the bank of suppliers until April 14, 2023, or until the limits of suppliers per topic are reached. The SMEs will only be able to choose suppliers registered in the Bank of Suppliers at the time of the application. You should also consider that you will get more SMEs viewing your entity the sooner you enter into the bank. The MedBAN consortium will ensure a geographical balance in the Bank of suppliers, in order to ensure that most SMEs have suppliers from their own country to choose from (although they can choose one from other country as well). For SMEs outside the consortium's five countries, new suppliers can join to the Bank until April 28, 2023 (inclusive). If an SME does not find any supplier to tackle their provision needs, the MedBAN consortium might allow a new supplier contact to join the Bank after April 28, 2023 upon a case-by-case analysis.

Duration

This commitment shall come into force on the date it is communicated by the MedBAN consortium that your organisation was accepted for the MedBAN Bank of Suppliers and shall remain effective until the conclusion of the MedBAN project on August 2024.
